## **Every Brief Encounter**

Most of the opportunities we will have to share our faith will not be public debates or lectures. They will come at times when we have little time to plan and a prepare right there. Yet if we have taken the time to equip ourselves carefully, we will be able to translate these moments into meaningful steps in the lives of others. Good apologists are good personal evangelists.
