Leadership and Gospel Faithfulness

There is a growing softness around the edges of biblical morality, on issues such as hell and judgment, sexual ethics. Theological liberalism always emerges when evangelicalism becomes embarrassed by its core convictions. What do you do with Christian colleagues who you have worked with closely in the past but have now shifted their ground on some basic and important principles? How can leaders remain faithful to the Gospel and Scriptures amid ethical challenges?

John Stevens is the National Director of the Fellowship of Independent Evangelical Churches, a family of over 500 Bible-centred churches in the UK, a position that he has held since 2010. Prior to this he was one of the founding pastors of City Evangelical Church Birmingham, which was planted in the centre of the UK's 2nd largest city in 1999. He was instrumental in starting the Midlands Gospel Partnership, was the course Director of the Midlands Ministry Training Course and is a visiting lecturer at Oak Hill Theological College. John is also one of the pastors of Christchurch Market Harborough, a church he helped to plant when he took up his current role. He was converted whilst studying law at Cambridge University, and after taking a post-graduate degree at the University of Oxford worked for 16 years as a University Lecturer, ending his career as Deputy Head of the Law School at the University of Birmingham.
