


The Imago Dei and the Sanctity of Life

'So God created mankind in his own image, in the image of God he created them; male and female he created them.'

(Genesis 1:27)

'Whoever sheds human blood, by humans shall their blood be shed; for in the image of God has God made mankind.'

(Genesis 9:6)



The sanctity of life

- All human beings are made in the image of God (Genesis 1:27)
- Taking the life of innocent human being intentionally is forbidden even on request (Genesis 9:6; Exodus 20:13; Deuteronomy 5:17)
- The Bible only sanctions the killing of 'guilty' human beings in specific circumstances (capital punishment, holy war, self-defence)
- Ratsach and Phoneuo (Exodus 21:12-14; Leviticus 24:17-21; Numbers 35:16-31; Deuteronomy 19:4-13)

The reason for the exile

'Surely these things happened to Judah according to the LORD's command, in order to remove them from his presence because of the sins of Manasseh and all he had done, including the shedding of innocent blood. For he had filled Jerusalem with innocent blood, and the LORD was not willing to forgive.'

(2 Kings 24:3,4)

A Christ-like approach

- Sharing the mind of Christ
- Holding the commands of Christ
- Displaying the character of Christ
- Carrying the cross of Christ

Christ-like mind

- Creation created 'image bearers'
- Humanity fallen from grace (flawed masterpieces)
- Redemption science, technology, God's wisdom and rebirth

• Future hope - resurrection into the new creation

Life before birth

- Over 60 biblical references to 'conception'
- Life before birth (Is 49:1; Je 1:5; Jb 10:8-9, 18-19; Gn 25:22-23; Ps 22:9,10, 51:5, 71:6, 119:73, 139:13-16; Ec 11:5; Is 44:2,34; Ho 12:3)
- Jesus present in the womb in the first month (Mt 1:18; Lk 1:15, 41-44)
- Jesus 'became flesh' in a moment of time (John 1:14; Aorist tense) and was 'made like his brothers in every way (Hebrews 2:17)

Status of the Embryo

Flawed arguments for demeaning the embryo

- Not capable of independent existence

- High mortality
- Arguments from twinning
- Conception is a process
- 'Theological arguments'


The politicisation of Darwinism

- Secular/Materialist
 - 1. Humans are just one of many species and the value of human life depends on its quality
 - 2. Only some human lives are persons worthy of respect
 - 3. The weak should be sacrificed for the strong
- Christian/Hippocratic
 - 1. Human beings are made in God's image and all human life is of infinite value
 - 2. Every human life is a person worthy of respect
 - 3. The strong should make sacrifices for the weak



Abortion worldwide

- 43 million abortions each year
- 57 million deaths each year from *all other causes*
- 6 million deaths from COVID in 2 years
- 55 million deaths in WW2
- Abortion banned in only 26 countries
- UN/UNFPA/IPPF pushing for more legalisation


Abortion worldwide

Artificial reproduction

 Fuelled by delayed reproduction, STIs and fall in babies for adoption

- 5 million babies worldwide
- Sperm and egg donation
- IVF, GIFT etc
- Commercial surrogacy

Prenatal selection

- Down syndrome, spina bifida, cystic fibrosis
- 8,000 genetic diseases
- Embryo screening, chorion villus biopsy, amniocentesis and ultrasound




- Assisted Suicide only



The most effective arguments against legalising euthanasia

Which battles are most easily winnable?

Where we have secular cobelligerents and the church has made as stand

- Euthanasia vulnerable people, difficulties in containment, law works
- Conversion therapy lack of evidence, overreaching opposition, autonomy
- Transgender ROGD, desistance, de-transitioning, feminist and LGB opposition
- Freedom of speech autonomy
- Sexual morality #metoo, sex abuse scandals, feminism

Co-belligerence

Co-belligerence

 Iraq War, Sunday trading, World poverty, Free speech, Euthanasia

 Enables joint action, pooled resources, communal work, strength in numbers, neutralises opposition, controls messaging

Risks dilution, tension and compromise



The key arguments against euthanasia

- A change in the law would place vulnerable people under pressure to request early death – therefore it should not be changed for a few persistent cases
- Incremental extension is inevitable once euthanasia/PAS is allowed in any circumstances
- Requests for euthanasia are extremely rare when patients needs fully met – therefore we need good palliative care
- The current law is clear and right and works it tempers justice with mercy



1. Vulnerable people will feel pressure

 Any change in the law to allow assisted suicide or euthanasia would place pressure on vulnerable people to end their lives for fear of being a financial, emotional or care burden upon others. This would especially affect people who are disabled, elderly, sick or depressed.

 Carers, relatives and health professionals would also feel pressure to participate

2. Incremental extension is inevitable

- Autonomy and compassion arguments can be applied widely
- Logical 'mission creep' using equality law
 - Terminally ill to chronically ill
 - Adults to children
 - Mentally competent to mentally incompetent
- Proposed safeguards don't work and aren't safe

Incremental Extension


 Better to call it 'mission creep' or 'incremental extension' rather than 'slippery slope'

- We see all of the following:
 - An increase in the number of cases
 - Spread to new categories of people
 - A change in the public conscience

Proposed safeguards don't work

- 'terminally ill'
- 'mentally competent'
- 'adult'
- storage of lethal drugs
- witness statements
- record keeping

Belgium - >24,000 euthanasia deaths since legalization



3. Good Palliative Care is better

Symptoms can be relieved

• Pain, nausea and other distressing symptoms can be treated

• Less than ten in 20,000 dying patients have ongoing requests for 'assisted dying'

• It's about the person not the disease

You can kill the pain without killing the patient

The real reasons are not medical

In Oregon the most common reasons for wanting assisted suicide are:

- decreasing enjoyment of life (90.1%)
- loss of autonomy (88.7%)
- loss of dignity (74.6%)
- We should not be providing lethal injections for what are in reality spiritual problems!

Why Lord Carey is so desperately wrong about legalising assisted suicide



Lord Carey, former Archbishop of Canterbury, has surprisingly come out today in favour of Lord Falconer's Assisted Dying Bill which is due to have its second reading in the House of Lords on Friday 18 July.

> Falconer advocates licensing doctors to dispense lethal drugs to mentally competent adults with a life

expectancy of less than six months and a 'settled wish' to die, in order that they might kill themselves (Falconer calls this 'assisted dying' but, legally speaking, it is assisted suicide for a specified subset of people).

The Church of England's position on the matter is (refreshingly) unequivocal:

'The Church of England cannot support Lord Falconer's Assisted Dying Bill... Patient safety, protection of the vulnerable and respect for the integrity of the doctor-patient relationship are central to the Church of England's concerns about any proposal to change the law. Our position on the current Bill before parliament is also consistent with the approach taken by the Archbishops' Council, House of Bishops and with successive resolutions of the General Synod.'

In response to Carey, the current Archbishop, Justin Welby, has said today that legalising 'assisted dying' would be 'dangerous, abusive and mistaken'.

'Abuse, coercion and intimidation can be slow instruments in the hands of the unscrupulous, creating pressure on vulnerable people who are encouraged to 'do the decent thing,' he writes in The Times.

'Even where such pressure is not overt, the very presence of a law that permits assisted suicide on the terms proposed by Lord Falconer is bound to lead to sensitive individuals feeling that they ought to stop 'being a burden to others'.

'What sort of society would we be creating if we were to allow this sword of Damocles to hang over the head of every vulnerable, terminally-ill person in the country?'

Lord Carey also previously held to the church's official position but for some reason, which remains a mystery to me even after reading his article today in the Daily Mail, he has now changed his view. I would have to say that I found his article quite unconvincing.

Carey first argues for a limited change in the law and makes reference to abuses in the Netherlands highlighted just this week in the Daily Mail: 'It would be outrageous if it were extended beyond the terminally ill to an ever-widening group of people, including the disabled and the depressed. Such a step would impose terrible pressures on some of the most vulnerable people in our society.'

Four pitfalls for Christians

Situation Ethics - 'All that matters is love'

Cheap grace - 'We are not under law but grace '

 Diversity - 'Ethics is a secondary issue over which Christians may disagree'

 Personal pietism - 'The world is not our problem and we should not impose our morality'

Situation Ethics

- Situation ethics says, 'All that matters is love' (Joseph Fletcher)
- It's true that love sums up the law (Mt 22:37-40; Gal 5:6, 14)
- But love goes beyond the law (Mt 5:20, 23:23; 1 Cor 4:16, 11:1; Eph 5:1,2; 1 Jn 2:6)
- And the law against killing is upheld in the NT (Mt 5:21-22; Rom 13:9,10; Jas 2:8-11; Rev 21:8,22:15)

Cheap grace

Cheap grace says, 'We are not under law but grace '

• It's true that we are saved by grace through faith and not by good works (Rom 5:1,2; Gal 2:16; Eph 2:8,9)

• But genuine faith is evidenced by repentance (turning from sin) and a changed life (Gal 5:16-26; Eph 2:10; Jas 2:14-26)

• The disobedient will not inherit the Kingdom of God (1 Cor 6:9,10; Gal 5:19-21; Rev 21:8, 22:15)

Diversity

 Diversity says, 'Ethics is a secondary issue over which Christians may disagree'

• It's true that there are secondary issues over which Christians may legitimately disagree (Rom 14; 1 Cor 8:1-13, 10:23-33)

• But this is nowhere taught about the shedding of innocent blood (Mt 5:21-22; Rom 13:9-14; Jas 2:8-11; Rev 21:8,22:15)

Personal Pietism

 Personal pietism says, 'The world is not our problem and we should not impose our morality'

• It is true that we are not of this world but citizens of God's Kingdom (Heb 11:16; 1 Pet 2:9,10)

• But as aliens and exiles we are to seek the good of the city in which we are placed (1 Pet 2:11-17; Je 29:7) and have a duty to seek justice (Mi 6:8; Amos 5:14,15,24; Pr 31:8,9)
